Nestled in the apple growing foothills of historic Oak Glen, Riley's Los Rios Rancho is a working apple orchard and living history farm featuring pick-your-own fruit. Devon and Shelli Riley are your hosts as you enjoy an afternoon of crisp, clean mountain air, a country lunch and entertainment at the oldest and largest ranch in Oak Glen. When you arrive, you'll start with chips and salsa and freshly popped popcorn while you get to know the Rileys and learn more about the ranch's history. During lunch, you'll be entertained by the Riley's Mountaineers (led by Pa Riley and kinfolk), singing some of your old favorite country and bluegrass tunes from bygone times. While visiting, you can pick your own apples, browse through the unique gift shop, take a walk through the beautiful apple orchards, see the vintage 1932 cider press that produces 100 gallons of cider per hour; or visit the old apple packing shed. You might also want to stop by the bakery and take one of Riley's 5-pound apple pies home with you!
