



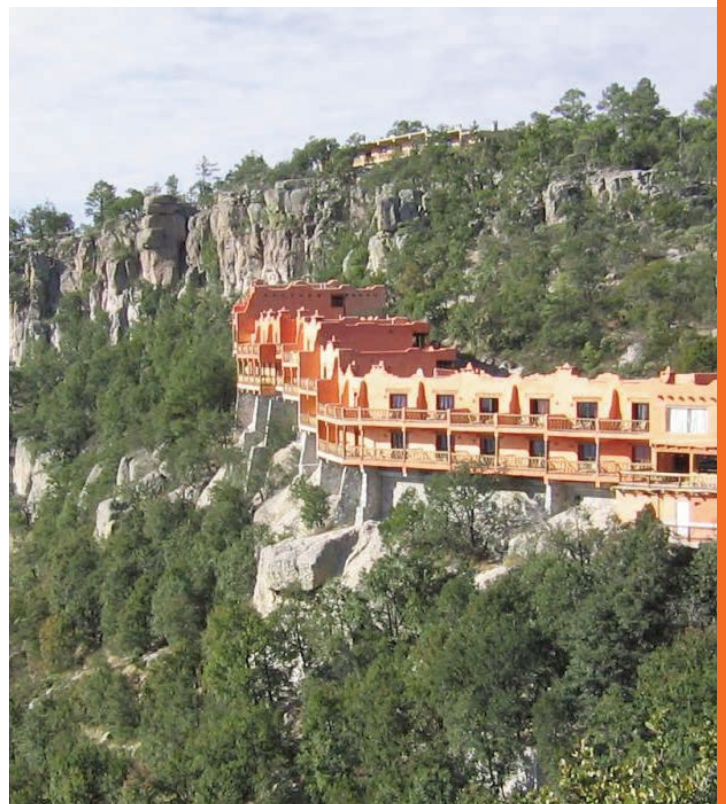

HOME OF THE TARAHUMARA INDIANS

DAY 1: SUNDAY, FEBRUARY 28, 2027

Fly to Tucson or Phoenix

Fly into the Phoenix or Tucson airport where you will transfer to a nearby hotel for a reception, orientation and overnight stay. (Arrival airport to be determined).

DAY 2: MONDAY, MARCH 1, 2027

Travel across the border to Mexico's Nuevo Casas Grandes

Our adventure into Mexico begins with an early morning departure is scheduled as we travel to the U.S.-Mexico border. After immigration formalities, enjoy lunch before continuing south to Nuevo Casas Grandes. Check in to the charming Los Cedros Hotel followed by a home-hosted welcome dinner and a special Mata Ortiz pottery demonstration highlighting the region's renowned ceramic traditions.

DAY 3: TUESDAY, MARCH 24, 2027

Chihuahua



UNESCO WORLD HERITAGE SITE PAQUIME

Enjoy breakfast at the hotel before departing to visit Paquime (Casas Grandes), Mexico's northernmost major archaeological site, where the ancient Grand Chichimeca civilization built distinctive truncated pyramids and multi-story adobe apartment complexes. We then travel south toward the city of Chihuahua, stopping along the way for lunch and to learn about the region's rich frontier history, including the Apache warriors who once traversed this land. Upon arrival in Chihuahua, check in at the Courtyard by Marriott. This evening, enjoy dinner at a local restaurant showcasing regional Chihuahua cuisine. (B, L, D)

DAY 4: WEDNESDAY, MARCH 3, 2027

Divisadero and the Copper Canyon

This morning after breakfast, we will leave the high planes of the Chihuahuan Desert and head for the Sierra Madre Mountains, home of the reclusive Tarahumara (Raramuri) people. Along the way, we'll stop in the Mennonite communities and enjoy lunch in the city of Cuatemoc. We then continue our scenic ascent into the mountains, traveling through Creel before arriving at Posada Barrancas in the afternoon. We will check in for two nights at the breathtaking Hotel Mirador, perched dramatically on the canyon rim. This evening you'll enjoy dinner overlooking the canyon and a fascinating Tarahumara cultural presentation. (B, L, D)

DAY 5: THURSDAY, MARCH 4, 2027

Free day and Aerial Tram Ride over the Copper Canyon



COPPER CANYON AERIAL TRAM

Today we enjoy a leisurely day surrounded by spectacular scenery, with time to watch Tarahumara artisans craft their world-famous baskets and browse a variety of local arts and handicrafts. A ride on the Copper Canyon aerial tramway offers a thrilling descent partway into the canyon, revealing sweeping, unforgettable views. Peaceful and remote, this day captures the quiet grandeur of the Copper Canyon and is sure to be a highlight of the journey. (B, L, D)



DAY 6: FRIDAY, MARCH 5, 2027

“Train ride in the Sky” through the Copper Canyon to El Fuerte

After breakfast overlooking the canyon, we'll transfer to the train station, as the conductors calls for “all aboard” the Chihuahua al Pacifico railway, “Chepe,” provides impressively unique access into Copper Canyon country and is considered one of the most scenic railroads in the world. On its 420 mile run, this engineering marvel goes through 86 tunnels and over 32 bridges, passing spectacular scenes of Mexico’s mountain interior, the Pacific coast, and every type of landscape in between. The “Train Ride in the Sky” is one of the most dramatic railway journeys in the Western Hemisphere. Lunch onboard the train is included as we snake our way through the spectacular Copper Canyon enroute to the colonial river town of El Fuerte. Here we'll check in to the historic Posada del Hidalgo located in the heart of this charming city. This evening, immerse yourself in the local culture with dinner and entertainment. (B, L, D)

DAY 7: SATURDAY, MARCH 6, 2027

Alamos



ALAMOS

We will depart El Fuerte after breakfast, stopping enroute for a home-hosted lunch in Navajoa before continuing on to the quaint city of Álamos. A living museum, the city’s cobblestones streets are lined with beautiful Spanish Colonial mansions. This evening immerse yourself in the local culture at dinner with a colorful spectacle of music and folk dancing by performers in traditional costumes. (B, L, D)

Enjoy a guided stroll through the cobblestone streets, visiting some famed mansions that have been restored to their original glory. The city of Álamos has been declared a national historic landmark by the government. Lunch today is at the hotel before we depart and travel north past the foothills of the Sierra Madre mountains and through rich grain farmlands. Arrive in San Carlos Bay by sunset to check in to the beautiful Marinaterra Resort for a two-night stay. Dinner is included this evening at the resort. (B, L, D)

San Carlos and the Sea of Cortez

After a relaxed breakfast, we board a private boat for a scenic cruise on the Sea of Cortez. Keep a lookout for dolphins, seals, and exotic birds such as the blue-footed booby and the magnificent frigatebird. We'll return to the resort for a poolside lunch and the afternoon at your leisure to relax and visit the Marina shops. A festive farewell dinner is included this evening as we share photos and memories of our Copper Canyon experience. (B, L, D)
