DAY 1: WEDNESDAY, MAY 1, 2024 - Travel to Texas

We'll begin our journey by flying out of Long Beach Airport to Austin, Texas. Upon arrival, you'll be greeted by your knowledgeable tour escort who will accompany you on this fun adventure. With over 270 live music venues, Austin is known as the Live Music Capital of the World! Many of these venues are located outside of downtown and tucked into neighborhoods, so come explore with a true Austin local as they show you some of Austin's best spots. Have fun jamming out to authentic live music all over the city! Along the way, we'll chat about Austin's live music history, get the latest scoop on the current music scene, and see iconic venues and new clubs. Our live music crawls are led by local music enthusiasts, artists, and performers. Check out live music shows at three different venues. This tour simply rocks!



DAY 2: THURSDAY, MAY 2, 2024 - Austin and Waco

Board the coach as we head to the *Texas Capitol Visitor Center* for a guided tour of the Texas Capitol. Located in the restored 1856-57 General Land Office building. The three-story castle-like structure is the oldest state office building in Texas. The 1990s building restoration identified spaces in the Capitol based on their historical and architectural significance. Preservationists returned these key areas to their 1888-1915 appearance with original or reproduction furniture as well as artwork and decorative elements. These significant spaces showcase the grandeur of the Capitol while remaining functional spaces for contemporary state government. For lunch, we will be treated to a delicious *Austin Eats Signature food tour*. The perfect mix of Swanky, BBQ & Casual bites. We will then depart Austin and make our way to Waco.(BREAKFAST AND LUNCH)

DAY 3: FRIDAY, MAY 3, 2024 - Fixer Upper

Calling all Fixer Upper fans! This amazing *Fixer Upper Tour* includes many of the homes, shops, and historical landmarks featured on the show as well as the Gaines' upcoming projects in the area. *YOU MAY EVEN GET TO GO INSIDE A HOME DONE ON THE SHOW!*Stops include JDH Iron Design. NOTE: Harp Design is permanently closed, but you will see the original shop and the Harp House. After the tour, we will visit the *Magnolia Market & the Silos*. Have lunch at one of the Food Trucks or Magnolia Table (former Elite Café now owned by the Gaines) or another local eatery. Hop on the Silo District Trolley (free) or the LaSalle-Circle Shuttle (\$1.50 fee each way) and shop til you drop! River Square Center is home to Spice Village (shown on episodes of the Fixer Upper) that features many different vendors. Not into shopping? Visit the Texas Ranger Hall of Fame & Museum or the Dr. Pepper Museum. This afternoon, you'll take river cruise before heading heading to dinner at a local restaurant. (BREAKFAST AND DINNER)





DAY 4: SATURDAY, MAY 4, 2024 - Dallas

Explore the third largest city in Texas on a *guided Dallas City tour*. We'll see Founders Plaza, Old Red Court House, JFK Memorial, Dallas City Hall, The Wilson Block (historic neighborhood, Queen Anne/Victorian Style Houses), The Art District (the largest in the world!), Dealey Plaza (JFK assassination Point) and much more. Then, we will visit the *Dallas Arboretum & Botanical Garden* for lunch and a guided tour. Next stop is *The Sixth Floor Museum* that chronicles the assassination and legacy of President John F. Kennedy. Look out the window and you'll see 1963. View historical artifacts that are exclusive to the Sixth Floor Museum. Located on the sixth floor of the Texas School Book Depository building - the very spot where the sniper's gun was found - lets you gain a feel for how things happened in 1963. DAY 5: SUNDAY, MAY 5, 2024 - Travel to Oklahoma

As the 13th presidential library, the *George W. Bush Presidential Library* promotes an understanding of the American presidency, examines the specific time in history during which President Bush served, and provides access to official records and artifacts from the George W. Bush Administration. We'll visit the George W. Bush Presidential Center to explore the museum exhibits that include A Nation Under Attack, Life in the White House, the interactive Decision Points Theater, a full-size replica of the White House Oval Office, and a massive 20-foot-tall, 360-degree LED screen showing high-definition multimedia clips blending art, history, and entertainment. Once on board, we will make our way to the Sooner State. Oklahoma is known for its cowboy culture, Native American history, and beautiful nature. This afternoon, we'll head to the *Vintage Sewing Machine Museum* for a guided tour. This museum is an amazing tribute to sewing machines, the art of sewing, and other textile and fiber arts. Sewing machines, ranging from the earliest-available domestic machines to huge industrials, are on display in their many rooms. Visitors can even use some of them! (BREAKFAST AND LUNCH)



ROGERS

DAY 6: MONDAY, MAY 6, 2024 - Will Rogers and Philbrook Museum of Art

We'll pay homage to an American vaudeville performer, actor, and humorous social commentator, Will Rogers. The *Will Rogers Memorial Museum* in Claremore features art and artifacts pertaining to the life of Oklahoma's favorite son, Will Rogers. Explore 12 galleries in the expansive 16,652 sq. ft. museum and you'll find countless photographs and manuscripts documenting Will Rogers' life. See original artwork by Charles Russell, Jo Davidson, Electra Waggoner, Wayne Cooper, Charles Banks Wilson and Count Tamburini. lassic Will Rogers movies also play in the museum daily. The site of the museum was originally acquired by Will Rogers to build a retirement home and was donated by his family after his passing. The grounds contain the tomb of Will Rogers chiseled with his famous quotation: "I never met a man I didn't like." The museum also contains a gift shop with books, CDs, videos, art, and scores of souvenir items. After lunch, we'll visit *Philbrook Museum of Art* for a guided tour. Formerly the home of oilman Waite Phillips, Villa Philbrook was given to the city of Tulsa and restored to preserve the grandeur of the 1920s. Philbrook exhibits more than 8,500 works of art at the original location and now boasts a second location downtown, featuring contemporary art. The museum has 23 acres of exquisite

English gardens and serves as many as 150,000 visitors annually. (BREAKFAST, LUNCH AND DINNER)

DAY 7: TUESDAY, MAY 7, 2024 - Pioneer Woman and Pawhuska

It's time to explore the Pioneer Woman's frontier as we travel to *Pawhuska for a guided tour*. We'll roam Pawhuska and the surrounding area enjoying views of the Osage Hills, Tallgrass Prairie, Drummond Ranch (if available) and much more! Feel like you've traveled back in time to the 1920's oil boom with stories of riches, historical buildings, famous cowboys, and Native Osage Culture. Discover why this is a little town with a big history! Then, we'll visit the Pioneer Woman Mercantile. *The Pioneer Woman Mercantile* is a destination bakery, deli, and general store in the heart of Osage County, Oklahoma.
