Tours, Inc., dba Main Street Tours and dba Main Street Experiences, is a tour operator specializing in providing our customers with group travel experiences, these terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. You are responsible for informing such other persons of all terms and conditions applicable to their travel arrangements.
