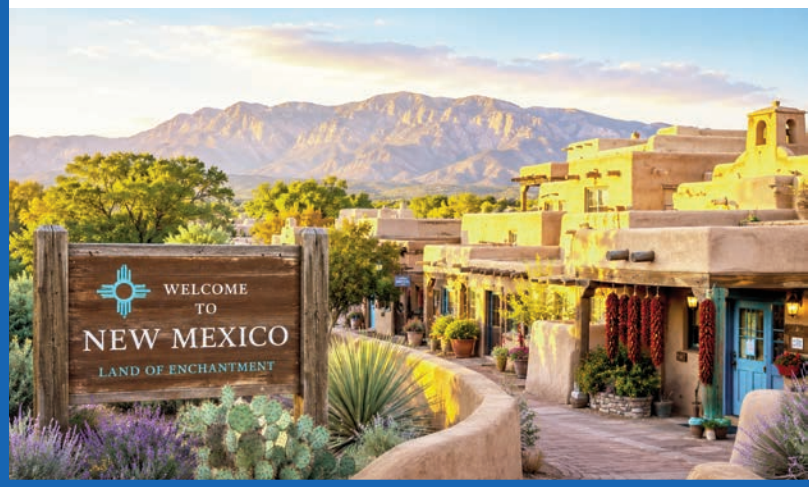

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

NON-OPERATION OF A TOUR

However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

CHANGES TO ITINERARIES
