Warning: This tour is designed specifically for "Chocoholics" and those with an unquenchable sweet tooth. You have been warned! This tour is provocative, complex, and tasty!

Our journey begins with some chocolate tasting on board the coach. Whether it's creamy Cadbury milk chocolate or a bittersweet Lindt 85% cacao dark chocolate, you'll have a chance to compare and choose your favorite!

Next up is a stop at a monastery in the hills above Hollywood Boulevard. For nearly a century, the cloistered nuns of the Monastery of the Angels have lived quietly on a rambling four-acre property just beneath the "H" of Los Angeles' famous Hollywood sign. From this peaceful location, they bake their famous pumpkin bread and make chocolates to sell at their gift shop. The delicious chocolates are known as "Better than the Best" and today we will sample their signature crunchy toffee with almond bits, covered in rich milk chocolate, their milk chocolate chewy caramel and crunchy bits of toasted almond, and their Dark chocolate surrounding a rich filling of chunky peanut butter.

For lunch we will stop at Philippe the Original. (lunch is on your own). This historic landmark that opened in 1908 is widely credited with the invention of the French Dip sandwich but not everyone knows they also make an incredible chocolate brownie. They are fudgy and delicious with the perfect crinkly crust on top. This thick and chewy brownie is flavored with the finest real vanilla, dark cocoa, and Ghirardelli chocolate. Baked to perfection and served daily at Philippe's!

In Little Tokyo/Japan Town you will have time to shop and explore after we visit a Japanese sweet shop called Fugetsu Do. Here the chocolate mochi recipe is a spin on the traditional Japanese rice cake but with added chocolate sweetness. Sometimes the pleasures of food aren't packed solely in remarkable tastes, but in textures. And when it comes to mochi, the Japanese rice dough, much of its appeal can be attributed to a glorious bounce and delicious squish.

Next is a stop is at Galco's Soda Pop Stop. This unique grocery store is a throwback to the age when every county had its own small soda manufacturer and every town its own beer brewery. This shop carries an immense variety of soda brands from all corners of the U.S., and as far away as Romania. Its catalog includes obscure, almost forgotten, old brands and imports available in only a few spots on the planet. Find flavors as strange as rose water and cucumber soda. Here you will take home a bottle of chocolate soda or an old-time chocolate bar.

Lastly, we will enjoy dessert at The Little Jewel of New Orleans Grocery and Deli in downtown L.A. Here you'll be treated to their delicious chocolate bread pudding washed down with a decadent chocolate martini! Let the good times roll!

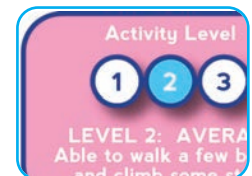

M.S. Tours, Inc., dba Main Street Tours and dba Main Street Experiences, is a tour operator specializing in providing our customers with group travel experiences. These terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through us.

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety. Pertaining to private group tours, the lead participant assumes the responsibility of sharing these Terms and Conditions with each trip participant, including payment of all amounts when due. M.S. Tours, Inc. is not responsible for any participant's unawareness of the Terms and Conditions due to the failure of the lead participant to share this information with all other participants/customers. If you do not agree to these terms you should not make a booking with us.

You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. You are responsible for informing such other persons of all terms and conditions applicable to their travel arrangements. You understand that you are financially responsible for any use of our services or website by you and those for whom you make bookings.

You agree that any violation of any such terms and conditions may result in (a) the cancellation of your reservation or purchase, (b) your forfeiture of any monies paid for your reservation or purchase, (c) you being denied access to the applicable travel related product or service, and (d) our right to debit your account for any costs we incur as a result of such violation.

If we do not receive any payment due in full and on time, M.S. Tours, Inc. may treat the booking as being cancelled by you in which case the cancellation charges set out below will become payable. We reserve the right to refuse a booking without giving any reason and shall, in that event only, return any deposit received. Reservations are non-transferrable.

The customer acknowledges that the price quoted for any tour or travel arrangements is based upon prices provided for accommodations, transportation, tickets and other components. Should any prices for such components be increased, M.S. Tours, Inc. reserves the right and the customer acknowledges the right of M.S. Tours, Inc. to increase the tour and travel arrangement price in the amount of any such increase in price. Any customer given notice of increased cost shall have the right to terminate the reservation and obtain a full refund of all amounts paid to M.S. Tours, Inc. unless such payment was expressly made on a non-refundable basis. The acceptance of any tickets, vouchers, or other documentation of tour or travel arrangements shall be deemed to be acceptance of the above General Information, Terms and Conditions by the customer.

PARKING

Parking at the departure point is free and at your own risk.

NON-OPERATION OF A TOUR

Most tours are based on a minimum number of participants. M.S. Tours, Inc. makes every effort to ensure that tours meet their minimum requirements. However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

CHANGES TO ITINERARIES

The customer acknowledges that tour itineraries, accommodations, travel arrangements and other aspects of a tour must at times be modified or cancelled due to acts of God, (including but not limited to, fires, earthquakes, floods, acts or threats of terrorism) unavailability of accommodations or other causes beyond the reasonable control of M.S. Tours, Inc.. M.S. Tours, Inc. reserves the right to make changes to its published itineraries which we deem insignificant and are due to reasons beyond our control. In such cases, we will arrange for the substitution of comparable services. As an example, significant changes do not include the following, change of accommodation to another of the same standard, any change in the itinerary due to holiday, facility closure or weather, and any minor itinerary change where we make a reasonable substitution. M.S. Tours, Inc. will not be responsible for delays prior to the departure of your tour, during the tour or at any time and will not be responsible for any additional cost or loss which may be caused as a result of these delays.

CANCELLATION BY M.S. TOURS, INC.

If for any reason M.S. Tours, Inc. cancels your trip, excepting in case of a force majeure, an alternative trip of a similar standard will be offered to you. If this is not acceptable to you, then all monies paid by you to M.S. Tours, Inc. will be refunded. Beyond the trip costs paid

to us, M.S. Tours, Inc. is not responsible for any loss or damage that arises out of any cancellation for any reason whatsoever.

FORCE MAJEURE

M.S. Tours, Inc. cannot accept liability, provide any refund, or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience or damage as a result of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid. Such events and circumstances may include, acts of God, actual or threatened, war, insurrection, riots, strikes, civil action, decisions by governments or governing authority, technical or maintenance problems with transport, changes of schedules or operational decisions of air carriers, terrorist activity or the threat thereof, industrial action, natural or nuclear activity, epidemic, pandemic, illness, physical injury, quarantine, medical or customs or immigration regulation, delay, or cancellation, adverse weather conditions, fire and all similar events outside our control.

YOUR CONDUCT/RESPONSIBILITY

We and our local guides and suppliers reserve the right to remove you from any trip if you endanger yourself or others or disrupt the general well-being of the trip itself. Full payment for any such damage or loss (reasonably estimated if not precisely known) must be paid direct at the time to the accommodation owner or manager or other supplier.
