These terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirely.. You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. NON-OPERATION OF A TOUR

We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

FORCE MAJEURE

Tours, Inc. cannot accept liability, provide any refund, or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience or damage as a result of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid.
