DAY 1: SATURDAY, NOVEMBER 30, 2024

Fly to Boston

Breakfast is included at our hotel before we depart for our journey to the Green Mountains of Vermont. Our first stop this morning takes us to the Quechee Gorge Village and Cabot Cheese Annex. We'll stop for photos at Quechee Gorge (Vermont's Little Grand Canyon) before continuing to Montpelier (Vermont's State Capital) where you will have time for lunch on your own. This afternoon we make a stop at the Morse Sugar Farm for a maple sugaring talk followed by a traditional sugar-on-snow. We continue north to Stowe, Vermont, home of the Trapp Family Lodge where we will check in for the next two evenings. A delicious dinner is served in the Main Dining Room this evening. Relax and enjoy the amenities or a film in the theater. (B, D)

DAY 3: MONDAY, DECEMBER 2, 2024

The Trapp Family Lodge and Stowe, Vermont

A fantastic breakfast is served in the Main Dining Room this morning before we meet with staff at the Lodge for a tour and talk about the history of the Trapp Family in Vermont. We will even have the opportunity to meet one of the surviving family members before departing for the morning. Our first stop this morning takes us to the Cold Hollow Cider Mill where you will see the production of their delicious cider and have the opportunity to sample many of their fine apple products. Later, we'll visit the charming town of Stowe where you will have free time for lunch and shopping on your own. This afternoon we're off to the Ben & Jerry's Ice Cream Factory for a little ice cream treat before concluding our day with a horse drawn sleigh ride. Dinner this evening is served at the Trapp Family Bier Hall. Enjoy a movie at the lodge following dinner. (B, D)



DAY 4: TUESDAY, DECEMBER 3, 2024


Holiday Shopping in Vermont and the Middlebury Inn

Breakfast is included this morning before we say good-bye to our mountainside accommodations. This morning we travel to the Christmas Loft for a little holiday shopping at the indoor Dickens Village. Next, we visit the Vermont Teddy Bear Factory for a guided tour to see how our furry friends are made. Following our visit, you will have time for lunch and shopping on your own at the historic Church Street Marketplace. This afternoon we travel south along Lake Champlain making a stop at Dakin Farms, known as "Vermont's Tastiest Attraction," where you will see the production of their gourmet meats and cheeses and sample some of their products. At the end of the day, we'll check into the historic Middlebury Inn where we will spend the next two evenings. A wonderful dinner is served at the inn. (B, D)



DAY 5: WEDNESDAY, DECEMBER 4, 2024
More touring and shopping in Vermont * Lunch at the Waybury Inn
(home of *The Bob Newhart Show*)

Breakfast is included this morning at the inn before heading out on another day of touring and shopping. Our first stop this morning finds us at Danforth Pewter where you will see the production of their beautiful pewter lamps and jewelry. Next, we visit Maple Landmark Toys before traveling to the Waybury Inn (Home of *The Bob Newhart Show*) for a lunch featuring their famous gingerbread dessert. This afternoon you will have time to visit the Sheldon Museum and explore downtown Middlebury to do a little more shopping. We will conclude our day with a tasting at a Vermont Cidery Company. A very special Christmas dinner is included followed by caroling in the living room at the historic Middlebury Inn. Everyone will receive a songbook copy as a gift from the inn. (B, L, D)



DAY 6: THURSDAY, DECEMBER 5, 2024
Vermont Country Store and Manchester, Vermont





M.S. Tours, Inc., dba Main Street Tours and dba Main Street Experiences, is a tour operator specializing in providing our customers with group travel experiences. These terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through us.

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety. Pertaining to group bookings, the lead participant or tour operator booking on behalf of the group assumes the responsibility of sharing these Terms and Conditions with each trip participant, including payment of all amounts when due. M.S. Tours, Inc. is not responsible for any participant's unawareness of the Terms and Conditions due to the failure of the lead participant to share this information with all other participants/customers. If you do not agree to these terms you should not make a booking with us.

You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. You are responsible for informing such other persons of all terms and conditions applicable to their travel arrangements. You understand that you are financially responsible for any use of our services or website by you and those for whom you make bookings.

You agree that any violation of any such terms and conditions may result in (a) the cancellation of your reservation or purchase, (b) your forfeiture of any monies paid for your reservation or purchase, (c) you being denied access to the applicable travel related product or service, and (d) our right to debit your account for any costs we incur as a result of such violation.

If we do not receive any payment due in full and on time, M.S. Tours, Inc. may treat the booking as being cancelled by you in which case the cancellation charges set out below will become payable. We reserve the right to refuse a booking without giving any reason and shall, in that event only, return any deposit received. Reservations are non-transferrable.

The customer acknowledges that the price quoted for any tour or travel arrangements is based upon prices provided for accommodations, transportation, tickets and other components. Should any prices for such components be increased, M.S. Tours, Inc. reserves the right and the customer acknowledges the right of M.S. Tours, Inc. to increase the tour and travel arrangement price in the amount of any such increase in price. Any customer given notice of increased cost shall have the right to terminate the reservation and obtain a full refund of all amounts paid to M.S. Tours, Inc. unless such payment was expressly made on a non-refundable basis. The acceptance of any tickets, vouchers, or other documentation of tour or travel arrangements shall be deemed to be acceptance of the above General Information, Terms and Conditions by the customer.

NON-OPERATION OF A TOUR

Most tours are based on a minimum number of participants. M.S. Tours, Inc. makes every effort to ensure that tours meet their minimum requirements. However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

CHANGES TO ITINERARIES

The customer acknowledges that tour itineraries, accommodations, travel arrangements and other aspects of a tour must at times be modified or cancelled due to acts of God, (including but not limited to, fires, earthquakes, floods, acts or threats of terrorism) unavailability of accommodations or other causes beyond the reasonable control of M.S. Tours, Inc. M.S. Tours, Inc. reserves the right to make changes to its published itineraries which we deem insignificant and are due to reasons beyond our control. In such cases, we will arrange for the substitution of comparable services. As an example, significant changes do not include the following, change of accommodation to another of the same standard, any change in the itinerary due to holiday, facility closure or weather, and any minor itinerary change where we make a reasonable substitution. M.S. Tours, Inc. will not be responsible for delays prior to the departure of your tour, during the tour or at any time and will not be responsible for any additional cost of loss which may be caused as a result of these delays.

CANCELLATION BY M.S. TOURS, INC.

If for any reason M.S. Tours, Inc. cancels your trip, excepting in case of a force majeure, an alternative trip of a similar standard will be offered to you. If this is not acceptable to you, then all monies paid by you to M.S. Tours, Inc. will be refunded. Beyond the trip costs paid to us, M.S. Tours, Inc. is not responsible for any loss or damage that arises out of any cancellation for any reason whatsoever.

FORCE MAJEURE

M.S. Tours, Inc. cannot accept liability, provide any refund, or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience or damage as a result of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid. Such events and circumstances may include, acts of God, actual or threatened, war, insurrection, riots, strikes, civil action, decisions by governments or governing authority, technical or maintenance problems with transport, changes of schedules or operational decisions of air carriers, terrorist activity or the threat thereof, industrial action, natural or nuclear activity, epidemic, pandemic, illness, physical injury, quarantine, medical or customs or immigration regulation, delay, or cancellation, adverse weather conditions, fire and all similar events outside our control.

PARKING

Parking at all departure points is at your own risk.

YOUR CONDUCT/RESPONSIBILITY

We and our local guides and suppliers reserve the right to remove you from any trip if you endanger yourself or others or disrupt the general well-being of the trip itself. Full payment for any such damage or loss (reasonably estimated if not precisely known) must be paid direct at the time to the accommodation owner or manager or other supplier.
