### DAY 4: SUNDAY, SEPTEMBER 7, 2025 Old Friends, Buffalo Trace and Gus's Fried Chicken

Today begins with a visit to the horses at Old Friends Thoroughbred Retirement Farm. You will get up close and personal with such stars of the turf as Kentucky Derby winner Silver Charm, Breeder's Cup Champion Amazombie and stakes winners Game On Dude and Ide. In Frankfort, a stop is made at Buffalo Trace Distillery.


