DAY 1 -- THURSDAY, SEPTEMBER 22, 2022 or THURSDAY, OCTOBER 13, 2022

INFLIGHT DINNER INCLUDED

FLIGHT FROM LOS ANGELES TO ROME, ITALY

Our adventure begins with an overnight flight to Rome, Italy.

DAY 2 -- FRIDAY, SEPTEMBER 23, 2022 or FRIDAY, OCTOBER 14, 2022

DINNER INCLUDED

ARRIVE IN ROME

Arrival at Rome Airport and transfer to our hotel in Rome for a 3-night stay. Upon arrival at the hotel, you'll have the remainder of the day at your leisure to acclimate to the new time zone. Your home for the next three nights is The Hotel Welcome Piram. Located just a few steps from the Opera House and the magnificent Santa Maria degli Angeli Basilica, the 4-star hotel is situated in the scenic setting of Piazza della Repubblica. You can easily reach the main shopping streets and the beauty of Roman architecture, like Via Veneto, Via Nazionale, the Spanish Steps, the Trevi Fountain and the Coliseum. A welcome dinner is included this evening at a nearby restaurant.

DAY 3 -- SATURDAY, SEPTEMBER 24, 2022 or SATURDAY, OCTOBER 15, 2022

BREAKFAST INCLUDED

THE VATICAN AND ANCIENT ROME

The Vatican Museums are, with more than 300 galleries, Rome's largest museum - an exhibition of art since its beginnings, displayed in rooms, which are already overwhelming in and of themselves, decorated by great artists for the various popes. The collection's spectrum ranges from Egyptian exhibits to Etruscan, Greek, and Roman sculptures (among others a Laocoon replica) and reliefs, up until the art of the Renaissance and the Baroque. The highlights are without a doubt two famous interior decorations - the Raphael Rooms, which were commissioned by Pope Nicholas V and cover several rooms, as well as the Sistine Chapel (1473-84) with its elaborately renovated frescoes and ceiling paintings - masterpieces by Michelangelo. The ancient Rome tour will lead you back to the glory days of the Roman Empire. You will travel back to the time of the gladiators and wander through the ruins of Rome. You will begin your 'journey through antiquity' on Capitoline Hill. After an in-depth explanation, you will see the remains of the great Roman era up close, before you climb onto Palatine Hill, to admire the ruins of the imperial palace complex. Next comes the visit to the Colosseum, then you will go back to the Piazza Venezia at the foot of Capitoline Hill. The evening is at your leisure to experience Rome at night!





DAY 4 -- SUNDAY, SEPTEMBER 25, 2021 or SUNDAY, OCTOBER 16, 2022

BREAKFAST INCLUDED

POMPEII

Today you will visit Pompeii, the city destroyed in antiquity by the devastating eruption of Mt. Vesuvius. The size of the ruins set amidst an idyllic landscape convey a lovely impression of what the city must have looked like during the period of the Roman Empire. During the tour you can admire the forum and the temples of Zeus and Apollo, the antique shops and the brothel, full of erotic paintings. We'll return to Rome for our last night in the Eternal City.

DAY 5 -- MONDAY, SEPTEMBER 26, 2022 or MONDAY, OCTOBER 17, 2022

BREAKFAST AND DINNER INCLUDED

FLORENCE

After breakfast, we'll check out and travel to the beautiful city of Florence. Florence's cathedral dominates the skyline and together with the Bell Tower and the Baptistery forms one of the most magnificent art masterpieces in the world. The austerity and beauty of this city, and the pride and determination of the Florentine artists are displayed in a unique way in the Palazzo Vecchio. With a local English-speaking guide we will discover the major sites before we have some free time to admire the jewelry stores on Ponte Vecchio or to enjoy an espresso coffee. Later we'll travel a short distance to the Tuscan spa town of Montecatini Terme where we'll check in to the lovely Hotel Adua for a relaxing 7-night stay in Tuscany.

DAY 6 -- TUESDAY, SEPTEMBER 27, 2022 or TUESDAY, OCTOBER 18, 2022

BREAKFAST AND DINNER INCLUDED

DAY AT LEISURE

Enjoy a full day at your leisure. Your tour director will be on hand to offer sightseeing suggestions, such as taking the funicular to the medieval hilltop village of Montecatini Alto. Or you may prefer to treat yourself at one of the thermal spas in town, check out the local shops, or simply relax and unwind poolside and grab an afternoon gelato!

DAY 7 -- WEDNESDAY, SEPTEMBER 28, 2022 or WEDNESDAY, OCTOBER 19, 2022

BREAKFAST, LUNCH AND DINNER INCLUDED

VOLTERRA AND A TUSCAN COOKING CLASS

After breakfast we make our way to the town of Volterra which stands mightily over the surrounding hills and villages. Our guided tour will begin by the great Medicea Fortress and take us to Via Panoramica which runs along the city walls. Enjoy the lovely view of the Roman Theater and the surrounding hilly countryside. Discover the secrets of Italian and Tuscan cuisine during a hands-on cooking class in the afternoon. After the class we will get together with the other participants to enjoy our own homemade meal. Buon appetito!

DAY 8 -- THURSDAY, SEPTEMBER 29, 2022 or THURSDAY, OCTOBER 20, 2022

BREAKFAST, LUNCH AND DINNER INCLUDED

THE CHIANTI WINE REGION AND SAN GIMIGNANO

We will spend today exploring the Chianti region of Italy. It begins with a stop in the village of Greve. The Franciscan monastery is still at the heart of the old part of the city, as is the triangular main piazza which is lined with unique shops. Next, we will cross the gently Chianti rolling hills before arriving at one of Tuscany's most beautiful wineries. Here we will enjoy a light lunch and a lesson in wine tasting. The experience concludes with their famous sweet Vin Santo and Cantucci cookies. Later, we will spend some time in San Gimignano, the "Manhattan of Tuscany" which announces itself with a skyline full of medieval towers that rise over 175 feet.



DAY 9 — FRIDAY, SEPTEMBER 30, 2022 or FRIDAY, OCTOBER 21, 2022

BREAKFAST, LUNCH AND DINNER INCLUDED

PASTA FACTORY TOUR IN LARI AND AFTERNOON IN MONTECATINI

In the morning we will travel to the beautiful village of Lari, which enjoys an exquisite location in the hills of Pisa surrounded by cypresses, olive groves and vineyards. We will visit the village's own pasta factory, owned and run by the Martelli family since 1926, which has been producing and exporting excellent pasta worldwide. After touring the small factory, we'll have a chance to taste the Martelli at a typical restaurant in Lari. Later, we will return to Montecatini with the remainder of the afternoon and evening at your leisure. Enjoy dinner at the hotel, or venture out to sample one of the many nearby restaurants. The funicular to Montecatini Alto is also a short walk from the hotel.



DAY 10 -- SATURDAY, OCTOBER 1, 2022 or SATURDAY, OCTOBER 22, 2022

BREAKFAST AND DINNER INCLUDED

EXPERIENCE THE CINQUE TERRE

Today we will explore the Cinque Terre, one of the most picturesque natural parks in Italy. The Italian Riviera is not short of rugged coastline or romantic towns and villages, but the five fishing communities of the Cinque Terre are its most iconic highlight. From La Spezia, we will take a boat which will leave us in Portovenere, then from Portovenere to Vernazza. We return to La Spezia by train where our coach will be waiting for us to bring us back to the hotel. This day promises to be one of the most memorable!



DAY 11 — SUNDAY, OCTOBER 2, 2022 or SUNDAY, OCTOBER 23, 2022

BREAKFAST, LUNCH AND DINNER INCLUDED

PISA AND LUCCA

This morning, we are headed to Lucca, a traditional Tuscan town, whose medieval walls are still well-preserved. Known as the city of 100 churches and being the birthplace of Puccini, it offers many interesting sights. On a guided tour we will explore the city that is considered to be Tuscany's open-air museum. We will then enjoy a light lunch at a farmhouse including bruschetta with cold pressed olive oil, olives and cold meats before making our way to Pisa, the former powerful sea-republic. We will visit the impressive Cathedral, the Baptistery and of course the world famous leaning Tower.



DAY 12 -- MONDAY, OCTOBER 3, 2022 or MONDAY, OCTOBER 24, 2022

After breakfast and a leisurely morning in Montecatini, we will make our way to the lovely hilltop town of Orvieto. You'll ride the funicular to the top of the rocky plateau set amidst vineyards and olive groves where you'll have time for lunch and some last minute shopping. Later, we'll transfer to Rome where we'll check in to the Rome Airport Hilton for our last night together.

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS
