#### YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

#### NON-OPERATION OF A TOUR

Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.
