### **ITINERARY**



**DAY 1: SUNDAY, DECEMBER 4, 2022**  
**Fly to Boston**

Today we board our flight for Boston, MA. We arrive in the late afternoon where we will be greeted by your coach, guide and driver. Tonight we overnight in Boston at the Embassy Suites Hotel. We will check into our hotel before going to dinner at one of Boston's popular restaurants. (D)

**DAY 2: MONDAY, DECEMBER 5, 2022**  
**Boston and the Green Mountains of Vermont**

Breakfast is included at our hotel before we depart for our journey to the Green Mountains of Vermont. This morning we make a stop at the famous Yankee Candles Factory Flagship Store. You will have time for shopping and lunch on your own. We continue our journey to the Green Mountains of Vermont. We'll make a stop at the top of Hogback Mountain for a scenic 100 mile view of southern Vermont. Our scenic drive continues past the Mount Snow and Stratton Mountain Ski Resorts before reaching our destination. We arrive in the charming town of Manchester where we check into the Hampton Inn for the next two evenings. A delicious dinner is included at a nearby restaurant. **DAY 3: TUESDAY, DECEMBER 6, 2022**  
**Touring and shopping in Vermont**

Breakfast is included this morning at the hotel before we start our day. We board the coach this morning for a short trip to the charming town of Weston (home of the Vermont Country Store). First we will take a detour to the Scott's Covered Bridge for a picture stop and then onto Weston. In Weston you will have some free time to explore the Country Store, sample many delicious Vermont foods, and visit the other shops and galleries in town. Next we travel back to Manchester where you will have time for a little shopping and lunch on your own. This afternoon we visit Hildene (summer home of Robert Todd Lincoln) for a tour of this beautiful Georgian style mansion decorated in the style of the family in 1912. If time permits, we will visit the Chocolatorium in Arlington for a talk, demonstration and sampling. Another wonderful dinner is served at a local restaurant. (B, D)

**DAY 4: WEDNESDAY, DECEMBER 7, 2022**  
**Woodstock and Stowe, Vermont**

Breakfast is served this morning at the hotel before departure. Today we journey to the historic town of Woodstock, VT. We'll board gondolas and take a scenic ride to the top of Killington Peak. Next you will enjoy some free time for lunch and shopping in the town of Woodstock. Be sure to visit one of Vermont's Oldest General Stores – Gillingham and Sons located in the center of town. This afternoon we make a stop at the Quechee Gorge for pictures followed by the Quechee Village and Cabot Cheese Annex for a little sampling. We continue to Stowe, VT where we check into the famous Trapp Family Lodge for the next two evenings. A wonderful dinner is included in the Main Dining Room this evening. Relax and enjoy your mountain surroundings. (B, D)







**DAY 5: THURSDAY, DECEMBER 8, 2022**  
**The Trapp Family Lodge and Stowe, Vermont**

A fantastic breakfast is served in the Main Dining Room. This morning we meet with staff at the Lodge for a tour and talk about the history of the Trapp Family in Vermont. We will have the opportunity to meet one of the surviving family before departing for the morning. Our first stop this morning takes us to the Cold Hollow Cider Mill where you will see the production of their delicious cider and have the opportunity sample many of their fine apple products. We visit the charming town of Stowe where you will have free time for lunch and shopping on your own. This afternoon we visit the Ben & Jerry's Ice Cream Factory for a little ice cream treat and conclude our day with a horse drawn sleigh ride. Another wonderful dinner is included at the lodge followed by a viewing of the film "The Real Maria".



**DAY 6: FRIDAY, DECEMBER 9, 2022**  
**Shelburne and Middlebury, Vermont**



Breakfast is included this morning before saying good-bye to the Green Mountains and traveling to the Champlain Valley. Our first stop takes us to the Vermont Teddy Bear Factory for a guided tour to see how our furry friends are made. Next we visit the Christmas Loft for a stroll through the Village of Shelburne in the 1800's. Twelve huge rooms of Yuletide surround the village filled with décor, ornaments, collectibles, lighting and much more. Enjoy lunch and shopping on your own at the Church Street Marketplace in downtown Burlington. Our afternoon will take us to Dakin Farms (Vermont's Tastiest Attraction) where you see the production of their delicious gourmet meats and cheeses. Our final stop today takes us to either a Vermont Cider or Brewery for a tour and tasting. We check into the historic Middlebury Inn located in the charming town of Middlebury. A delicious dinner is included this evening. (B, D)





**DAY 7: SATURDAY, DECEMBER 10, 2022**

**More touring in Vermont \* Lunch at the Waybury Inn (home of the Bob Newhart Show)**

Breakfast is included this morning at the inn. Our first stop this morning takes us to the Vermont Folk Life Center to learn about the early history and people of Vermont. (Depending on timing a Vermont Gingerbread Contest may be happening). Next we visit Maple Landmark Toys before traveling to the Waybury Inn (home of the Bob Newhart Show) for a light lunch featuring their famous gingerbread dessert. This afternoon we visit the Danforth Pewter Company for a spinning demonstration and a little shopping. Our day concludes with a tasting at a Vermont cidery. A traditional Christmas dinner is included followed by caroling in the living room at the Middlebury Inn. Everyone will receive a souvenir songbook as a gift from the inn. (B, L, D)

### YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety. You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. We reserve the right to refuse a booking without giving any reason and shall, in that event only, return any deposit received. Reservations are non-transferrable.

The customer acknowledges that the price quoted for any tour or travel arrangements is based upon prices provided for accommodations, transportation, tickets and other components. Should any prices for such components be increased, M.S. Tours, Inc. reserves the right and the customer acknowledges the right of M.S. Tours, Inc. to increase the tour and travel arrangement price in the amount of any such increase in price. Any customer given notice of increased cost shall have the right to terminate the reservation and obtain a full refund of all amounts paid to M.S. Tours, Inc. unless such payment was expressly made on a non-refundable basis. The acceptance of any tickets, vouchers, or other documentation of tour or travel arrangements shall be deemed to be acceptance of the above General Information, Terms and Conditions by the customer.

### NON-OPERATION OF A TOUR

Most tours are based on a minimum number of participants. M.S. Tours, Inc. makes every effort to ensure that tours meet their minimum requirements. However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

### CHANGES TO ITINERARIES

The customer acknowledges that tour itineraries, accommodations, travel arrangements and other aspects of a tour must at times be modified or cancelled due to acts of God, (including but not limited to, fires, earthquakes, floods, acts or threats of terrorism) unavailability of accommodations or other causes beyond the reasonable control of M.S.
