### DAY 1: WEDNESDAY, OCTOBER 4, 2023

#### Fly to Chicago



Chicago is America's third largest city and boasts a friendly, Midwest atmosphere. For those arriving early, your hotel is close to the Lake Michigan waterfront. Visit one of Chicago's great museums or stroll along the "Magnificent Mile." Your Tour Manager is available in the lobby at 6:00 p.m. to assist with check-in and can offer suggestions for dining this evening.

### DAY 2: THURSDAY, OCTOBER 5, 2023

#### Travel to Michigan

This morning, begin the day with a panoramic tour of downtown Chicago with a local guide. Leave the big city behind for charming Traverse City, Michigan, known for its sparkling beaches, unique shops and cherry orchards. *Meals included: D*



### DAY 3: FRIDAY, OCTOBER 6, 2023

#### Sleeping Bear Dunes National Lakeshore



Begin your day exploring Sleeping Bear Dunes National Lakeshore that was named for an Indian legend. These expansive golden dunes stretch for more than 35 miles along the twinkling blue waters of Lake Michigan. A local guide tells the history and lore of the area including the peninsula and lighthouse. You're treated to a one-of-a-kind collection of rare antique musical instruments and musicmaking machines, from 1870 through 1930 at the Music House Museum. Nickelodeons, music boxes, pipe organs and a Belgian dance organ come alive. *Meals included: B*

### DAY 4: SATURDAY, OCTOBER 7, 2023

#### Agawa Canyon Autumn Foliage Train

Today, cross the border into Canada to board the Algoma Central Railway for a spectacular train ride through scenic Agawa Canyon during autumn foliage time. This all-day adventure takes you past massive rock formations, through thick forests of maple and birch and over pristine streams and lakes as you wind your way to Agawa Canyon. Explore the Agawa River and its waterfalls on the valley floor before returning to Sault Ste. Marie. *Meals included: B, L*






**DAY 5: SUNDAY, OCTOBER 8, 2023**  
**Mackinac Island's Grand Hotel**

A trip to Mackinac Island is like a trip back in time. From its bluff cottages to its quaint horse-drawn carriages (no cars are allowed on the island), this peaceful resort island offers a glimpse into life during a simpler and more genteel era. Upon arrival, tour the Island via horse-drawn carriage and step back in time as you enjoy the atmosphere of this unique treasure. At the end of the tour, the carriage brings you to the crown jewel of Mackinac Island, the Grand Hotel, the world's largest summer hotel, built in 1897, and your home for the next two nights. *Meals included: B, D*



**DAY 6: MONDAY, OCTOBER 9, 2023**  
**Explore Mackinac Island**

You will have the entire day at leisure on Mackinac Island. Browse the many shops, visit historic Fort Mackinac or rent bikes and peddle along the coast of Lake Huron. "The Grand" is a venerable island institution and the perfect place to enjoy a stroll in the landscaped gardens or enjoy afternoon tea. Don't forget to sample the world-famous Mackinac Island fudge! During the day enjoy a private lecture with a local historian to learn the history of the island. *Meals included: B, D*



**DAY 7: TUESDAY, OCTOBER 10, 2023**  
**Traveling in the Great Lakes State**

Leave Mackinac Island today and travel through the Great Lakes State. Michigan has the unique distinction of being surrounded by four of the five Great Lakes. Your destination is Dearborn, the heartland of the Ford Motor Company. *Meals included: B*





**DAY 8: WEDNESDAY, OCTOBER 11, 2023**

**Ford River Rouge Factory Tour and The Henry Ford Museum**

This morning, you go behind the scenes at the world’s largest automotive complex as you watch the Ford F150 pickup truck being built on a Ford Motor Company factory tour. 



M.S. Tours, Inc., dba Main Street Tours and dba Main Street Experiences, is a tour operator specializing in providing our customers with group travel experiences. These terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through us.

### YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety. Pertaining to group bookings, the lead participant or tour operator booking on behalf of the group assumes the responsibility of sharing these Terms and Conditions with each trip participant, including payment of all amounts when due. M.S. Tours, Inc. is not responsible for any participant's unawareness of the Terms and Conditions due to the failure of the lead participant to share this information with all other participants/customers. If you do not agree to these terms you should not make a booking with us.

You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. You are responsible for informing such other persons of all terms and conditions applicable to their travel arrangements. You understand that you are financially responsible for any use of our services or website by you and those for whom you make bookings.

You agree that any violation of any such terms and conditions may result in (a) the cancellation of your reservation or purchase, (b) your forfeiture of any monies paid for your reservation or purchase, (c) you being denied access to the applicable travel related product or service, and (d) our right to debit your account for any costs we incur as a result of such violation.

If we do not receive any payment due in full and on time, M.S. Tours, Inc. may treat the booking as being cancelled by you in which case the cancellation charges set out below will become payable. We reserve the right to refuse a booking without giving any reason and shall, in that event only, return any deposit received. Reservations are non-transferrable.

The customer acknowledges that the price quoted for any tour or travel arrangements is based upon prices provided for accommodations, transportation, tickets and other components. Should any prices for such components be increased, M.S. Tours, Inc. reserves the right and the customer acknowledges the right of M.S. Tours, Inc. to increase the tour and travel arrangement price in the amount of any such increase in price. Any customer given notice of increased cost shall have the right to terminate the reservation and obtain a full refund of all amounts paid to M.S. Tours, Inc. unless such payment was expressly made on a non-refundable basis. The acceptance of any tickets, vouchers, or other documentation of tour or travel arrangements shall be deemed to be acceptance of the above General Information, Terms and Conditions by the customer.

### NON-OPERATION OF A TOUR

Most tours are based on a minimum number of participants. M.S. Tours, Inc. makes every effort to ensure that tours meet their minimum requirements. However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

### CHANGES TO ITINERARIES

The customer acknowledges that tour itineraries, accommodations, travel arrangements and other aspects of a tour must at times be modified or cancelled due to acts of God, (including but not limited to, fires, earthquakes, floods, acts or threats of terrorism) unavailability of accommodations or other causes beyond the reasonable control of M.S. Tours, Inc. M.S. Tours, Inc. reserves the right to make changes to its published itineraries which we deem insignificant and are due to reasons beyond our control. In such cases, we will arrange for the substitution of comparable services. As an example, significant changes do not include the following, change of accommodation to another of the same standard, any change in the itinerary due to holiday, facility closure or weather, and any minor itinerary change where we make a reasonable substitution. M.S. Tours, Inc. will not be responsible for delays prior to the departure of your tour, during the tour or at any time and will not be responsible for any additional cost of loss which may be caused as a result of these delays.

### CANCELLATION BY M.S. TOURS, INC.

If for any reason M.S. Tours, Inc. cancels your trip, excepting in case of a force majeure, an alternative trip of a similar standard will be offered to you. If this is not acceptable to you, then all monies paid by you to M.S. Tours, Inc. will be refunded. Beyond the trip costs paid to us, M.S. Tours, Inc. is not responsible for any loss or damage that arises out of any cancellation for any reason whatsoever.

### FORCE MAJEURE

M.S. Tours, Inc. cannot accept liability, provide any refund, or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience or damage as a result of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid. Such events and circumstances may include, acts of God, actual or threatened, war, insurrection, riots, strikes, civil action, decisions by governments or governing authority, technical or maintenance problems with transport, changes of schedules or operational decisions of air carriers, terrorist activity or the threat thereof, industrial action, natural or nuclear activity, epidemic, pandemic, illness, physical injury, quarantine, medical or customs or immigration regulation, delay, or cancellation, adverse weather conditions, fire and all similar events outside our control.

### PARKING

Full payment for any such damage or loss (reasonably estimated if not precisely known) must be paid direct at the time to the accommodation owner or manager or other supplier.
