YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S.
